


Online Dynamic Auctions -

Almost any enterprise can take advantage of an Online Dynamic Auction. Selling items in such an auction involves placing the items for bidding and allowing buyers to bid against each other for the items. New surplus, off-lease, overstocked, refurbished, used items, all types of machines (GPMs / SPMs), project leftovers like pipes, valves, fittings etc., all types of scrap, power transmission related assets like transmission lines, penstocks etc are typically sold in this format. These items are typically hard to price in a fixed format. But the dynamic nature of auctions allows an item to rise to its market value.

Private Treaty Sales -

Private treaty sales are generally suited for situations in which the asset needs a longer period of exposure and a more targeted approach to potential buyers. Assets sold via Private Treaty tend to be more specialized or complex. In these situations, Synise with its National presence, domain expertise and huge database is able to reach out to large number of potential buyers.

Typically, the entire plant along with land and machinery, special purpose machines are some of the assets that can be handled under Private Treaty Sale. This process is highly specialized and involves a lot of back end work such as data

collection, detailing, asset marketing strategy, etc. It also involves high-end market making services in terms of identifying the right buyer and mediating between the buyer and seller with regard to detailed inspection of assets and the related technical and financial discussions. Private Treaty Sales is generally restricted to only 1-2 buyers, which could be companies trying to enter into new business areas or companies wanting to expand their existing capacities, companies interested in replacing existing plants/process lines etc.

e-Tenders -

Manual tender processes can be long and

cumbersome often taking more than a month, which is costly for both buyer as well as seller. e-Tendering replaces this manual paper based tender processes with electronically facilitated process based on best tendering practices to save time and money.

Asset Sourcing -

Many large and small manufacturing and other organizations are looking for specific assets that may be used. We are in a position to locate good value assets such as machineries and equipments or complete plants with or without technology transfer or for that matter sourcing of recurring supply of machines.

Asset Mapping -

As most of the organizations expand they need to transfer assets from one location to another and from this location to a third location and it is possible that the organization loses track of the asset. Further, in a multi location plants it is possible that certain machineries required in particular are available at another plant. But due to non-availability data new machineries are procured. Also the Companies' Act, 1956 mandates Statutory Auditors to report on the physical verification of assets by the management. 
